Disqualification from sitting as a Governor. Governing Bodies and governors should also note the changes reported in the Summer Term 2005, of the Education (Company Directors Disqualification Act 1986: Amendments To Disqualification Provisions) (England) Regulations 2004 and any declarations should reflect these changes. These changes have been reflected in an amendment to this Register of Interest Form, whereby all governors in signing it are declaring that they know of no reason why they should be statutorily debarred from continuing to serve as a school governor. To claim this in the knowledge that this is not the case, would be deemed a serious, possibly fraudulent matter. The Headteacher shall keep a register of staff and Governors' pecuniary interests and it shall be obligatory for each person to declare and have recorded in the register, any interest which either s/he or their spouse (or partner) may have. The Headteacher is also obliged to give a nil return when appropriate and to provide a further notice when the information within the original declaration has changed.
